ORDER

- 1. As per Clause 19.13 of the Regulations of the Calicut University Four Year UG Programmes (CUFYUGP Regulations 2024) for Affiliated Colleges, implemented vide paper read as (1), " In semesters I, III, V and VII, the colleges shall conduct the end-semester examination of all the courses, and they shall also conduct the evaluation of the answer sheets of these courses under the supervision of the University. In semesters II, IV, VI and VIII, the University shall conduct the end-semester examination of all the courses, with the question papers from the question bank prepared by the Boards of Studies in the respective disciplines, and shall also conduct the centralised evaluation for these courses. Until the question bank system is fully established, the University shall set the centralized timetable and prepare the question papers for the examinations as per the existing procedure in both the even and odd semesters".
- 2. Considering the huge number and variety of minor courses offered under CUFYUGP and the difficulty likely to be faced in the conduct of examinations for Minor Courses as per the centralized timetable set by the University, CUFYUGP Steering Committee, vide paper read as (2), proposed the following recommendations:
- The colleges shall conduct examinations for minor courses of first semester of 2024 admission, by setting the Question Papers and preparing the Timetable.
- For conducting the examinations of Major and General Foundation Courses of first semester of 2024 admission, the University shall prepare the centralized timetable and set the question papers for the examinations as per the existing procedure.
- 3. The aforesaid procedure is temporary and is applicable only for the first batch under CUFYUGP (2024 admission only).
- 4. The recommendations of the Steering Committee have been approved by the Vice-Chancellor, subject to ratification by the Academic Council, as per Clause 22.1 of CUFYUGP Regulations 2024.

- 5. Sanction has, therefore, been accorded for the following, with regard to the conduct of first semester examinations, applicable only for the first batch under CUFYUGP (2024 admission only), subject to ratification by the Academic Council:
 - Colleges shall conduct examinations for minor courses, by setting the Question Papers and preparing the Timetable.
 - For conducting the examinations of Major and General Foundation Courses, the University shall prepare the centralized timetable and set the question papers for the examinations as per the existing procedure.
- 5. Orders are issued accordingly.
